SECURING YOUR APPOINTMENTS

- Please fill out Page 3 and Page 4 of the Bridal Agreement and return them as soon as possible to Eclips Salon and Day Spa at 303 W. Water Street Decorah, IA 52101 or email to eclipssalonanddayspa@hotmail.com.
- Please share the information on Page 2 with all members of your party to ensure that each member understands her responsibility for her appointment and how to properly prepare for her appointment.
- To guarantee that all members of your party are responsible for his or her appointments, and to avoid any burden placed on the bride, we require that all members of your party pay for his or her services no later than two weeks prior to your scheduled day. This allows for your special day to run as smoothly as possible and helps to eliminate any unforeseen expenses and stress on the bride.
- Services can be pre-paid in person or over the phone using , Visa, or MasterCard

CHANGES AND/OR CANCELLATIONS

- Any cancellations or changes made at least 24 hours in advance will not be subject to charge
- Any cancellations made fewer than 24 hours prior to originally scheduled day will result in 50% charge of total service amount.
- Any “no shows”, or failure to fulfill an appointment without notice, will result in a charge of the total service amount.

HOW TO PREPARE FOR YOUR APPOINTMENT

- We suggest scheduling a practice appointment for your desired services prior to your wedding date. This will help both you and your stylist get a better idea of the look you want to achieve and safeguard that you are completely satisfied. Regular prices do apply for practice sessions.
- Please arrive 15 minutes prior to you and/or your party’s scheduled appointment(s)
- Do NOT shampoo and/or condition your hair the day of your appointment. Day-old hair is ideal, as it helps to hold curls much better than freshly shampooed hair. If you arrive with damp or wet hair, you will be charged an extra \$10.00 for drying.
- To help keep your appointments on time it is helpful for members of your party to arrive at their appointments with some idea of what style they are looking for. You can either bring in pictures from magazines or the internet or come 10 to 15 minutes early to look through some of our styling books. This also makes sure that our stylists can come as close as possible to creating your dream look.
